Clinical Trial Sweepstakes

DATES OF SWEEPSTAKES: The Kindred Bio “Clinical Trial” Sweepstakes (the “Sweepstakes”) begins at 12:00:00am Central Standard Time (“CT”) on May 1, 2021 and ends at 11:59:59pm on October 31, 2022 (the “Sweepstakes Period”).

SPONSOR: Kindred Bio, 1555 Bayshore Hwy, Suite 200, Burlingame, CA 94010.

ELIGIBILITY: In order to be eligible for entry into the Sweepstakes, you must be: i) a legal resident of the forty-eight (48) contiguous United States or the District of Columbia and eighteen (18) years or older, ii) reside within a clinical trial zip code area listed on the Website (defined below), and ii) the owner of a canine throughout the Sweepstakes Period and awarding of the prize (the “Entrant”). Upon completion of the Entry Form, click the “ENTER NOW” button to receive one (1) entry into the Sweepstakes. **There is a limit of one (1) entry per Entrant.**

In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed submitted by the authorized account holder of the e-mail address submitted at the time of entry. The “Authorized Account Holder” is defined as the natural person who is assigned to the e-mail address by an Internet access provider, on-line service provider, or other organization that is responsible for assigning e-mail addresses, or the domain associated with the submitted e-mail address. Potential Grand Prize Winner (defined below) may be required to show proof of being the Authorized Account Holder.

Grand Prize winner will also be awarded up to \$5,000 to be used towards the applicable registration, license, title, sales tax and

insurance fees and will be directly paid to the dealership. Grand Prize winner will be solely responsible for any applicable registration, license, title, sales tax and insurance fees, and any other expenses not listed herein related to the acceptance and use of the Grand Prize that exceeds \$5,000. Grand Prize Winner consents to Sponsor's use of his/her name, likeness, biographical information, image, and/or voice and other indicia of persona for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission or approval (TN residents will not be required to sign a publicity release as a condition of winning a prize).
